






Figure 1. Pulse Width





Figure 2. 8 \times 20 μs Pulse Waveform





Figure 4. Capacitance






Figure 5. Forward Voltage

Figure 6. Clamping Voltage versus Peak Pulse Current (Reverse Direction)




Figure 7. Clamping Voltage versus Peak Pulse Current (Forward Direction)
